MANY HANDS

One in seven individuals in our area will face food insecurity this year. Here at the Foodbank, we are helping to improve the lives of those in our community facing hunger, but we can't do it alone. In 2015, the Foodbank hosted 9,000 **volunteers** who donated more than 53,000 hours to hunger-relief efforts in our community! That's the equivalent of 25 full-time employees!

The Foodbank believes in the importance of **nutrition** and that sharing and distributing knowledge about **healthy foods** is a key factor in reducing hunger. The Foodbank collaborates with its partner hunger-relief programs by providing nutrition **education** opportunities like cooking demonstrations utilizing healthy foods that we distribute, and by providing resources like brochures and recipe cards highlighting nutritional benefits. Because of this emphasis, in 2015, your Foodbank distributed 7.7 million pounds of nourishing, fresh produce!
